### OFFICIAL RULES

#### CONTEST ENTRY RULES

Members of CAA-Québec, on the occasion of Earth Day 2017, Jour de la Terre, Société de transport de Montréal (STM) and the Ministère des Transports, de la Mobilité durable et de l'Électrification des transports, in collaboration with CAA-Québec, wish to offer CAA-Québec members the chance to win one month of public transit on the STM network. Fifty lucky members will be able to take advantage of a monthly OPUS card and an online OPUS card reader, allowing them to purchase transit passes from home. Two tools to make your public transit trips easier!

#### ELIGIBILITY

1. This contest is only addressed to CAA-Québec members who are age 18 and over and residents of Québec. Excluded are employees of CAA-Québec and Jour de la Terre, Société de transport de Montréal and their subsidiaries and the members of their immediate family (brothers, sisters, children, father, mother), their legal or de facto spouse and all the persons with whom these employees, agents and representatives are domiciled.

#### HOW TO ENTER

- a) From April 4 at 0:00 (midnight) EDT to April 14, 2017 at 3:00 p.m. EDT, the persons interested in entering must go to the Jour de la Terre website at the following Internet address: <http://www.jourdelaterre.org/qc/22-avril/programmes/opus-du-jour-de-la-terre/participe-in-the-program/> and complete the entry form appearing on the home page.
- b) No purchase required.
- c) There is a limit of one entry per person for the duration of the contest.

#### PRIZES

2. A total of 50 prizes will be offered, for a total value of \$5,283. Draw of 50 gift sets containing an OPUS card with the STM May monthly pass and an online OPUS card reader (Value of the prize: \$105.66 all taxes included).



## **DRAW**

3. To award the prizes described above, the 50 winners will be selected at random from the entries received.
4. *The draw will be held at the office of Jour de la Terre, located at 5818 Boulevard Saint-Laurent, Montréal, Québec H2T 1T3 Canada, on April 15, 2017 at 1:00 p.m. EDT. The winners will be announced between April 15 and April 22, 2017 (Earth Day).*
5. *The chances of winning depend on the number of valid entry forms during the contest period.*

## **GENERAL CONDITIONS**

1. To be declared winners, the persons selected for the prize must:
  - a) Be reached by phone or email by the contest organizers within two (2) days of the random selection;
  - b) Answer in writing that they accept the prize within three (3) days of the winning notice that will have been addressed to them;
  - c) The gift sets (OPUS card and online OPUS reader) will be sent to the winners by mail;
  - d) Complete and sign the Declaration and Waiver of Liability form (hereinafter the "Declaration Form") when the prize is awarded.
2. In default of compliance with one of the above-mentioned conditions, or any other condition set out in these rules, the persons selected will be disqualified and a new draw for this prize may be held in accordance with these rules until a participant is selected and declared a winner. However, the deadlines reproduced in point 1 will be shortened.
3. Any electronic participation or any declaration form that is, as the case may be, incomplete, fraudulent, or sent or transmitted late, that does not allow the participant to be identified or that is otherwise non-compliant, may be rejected and will not give entitlement to an entry or a prize, as the case may be.
4. Any decision of the organizers or mandators of the contest or their representatives regarding this contest may not be appealed, subject to any decision of the Régie des alcools, des courses et des jeux du Québec, in relation to any question within its jurisdiction.
5. The organizers and mandators of the contest reserve the right to disqualify a person who enters or attempts to enter this contest by using any means contrary to these rules or of such nature as to be unfair to the other participants (e.g. entries



- beyond the permitted limit, use of multiple email addresses, etc.). This person could be referred to the competent judicial authorities.
6. The organizers and mandators of the contest, their advertising and promotion agencies, and their employees, agents and representatives will not be responsible for lost, misrouted or late entries, including those due to a computer problem or related to the server or telecommunications services.
  7. The prize shall be accepted as described in these rules and may not be transferred to another person or replaced with another prize.
  8. The selected participants release from all liability the organizers and mandators of the contest, their advertising and promotion agencies, and their employees, agents and representatives, for any harm they might suffer due to the acceptance or use of their prizes, particularly any tax consequences. To be declared winners, and prior to obtaining their prizes, the participants undertake to sign a Declaration Form to this effect.
  9. The organizers and mandators of this contest at all times reserve the right, at their complete discretion, to cancel, terminate, modify or suspend this contest, in whole or in part, in the contingency of the occurrence of any event or any human intervention that could corrupt or affect the administration, security, impartiality or running of the contest, as provided in these rules. In all cases, the organizers and mandators of the contest, their subsidiaries, their advertising and promotion agencies, their suppliers of goods or services related to this contest, and their employees, agents and representatives, may not be bound to award more prizes than are provided for in these rules or to award the prize otherwise than in accordance with these rules.
  10. By entering this contest, the winners authorize the organizers, the mandators and their representatives to use, if required, their names, photographs, images, statements regarding the prizes, places of residence and/or voices for advertising purposes, without any form of remuneration. Every winner undertakes to sign a form to this effect, if required.
  11. By entering or attempting to enter this contest, every person releases from all liability the organizers, the mandators, their subsidiaries, their advertising and promotion agencies, and their employees, agents and representatives, for any harm they might suffer due to their entry or attempt to enter the contest.
  12. No communication or correspondence will be exchanged with the participants, except for the purpose of providing them with their prizes.
  13. For the purposes of these rules, the participants are the persons whose names appear on the entry forms. The prize will be remitted to these persons if they are selected and declared winners.
